On 10/03/22, FAA sent an Aircraft Registration EXPIRED - N Number Pending Cancellation Notice to [REDACTED] which states, in part, that the registration of N93381 expired on 08/31/22.

The aircraft's registration and airworthiness certificates no longer support the aircraft's operation. The N-number is no longer authorized for use and its assignment to this aircraft is scheduled for cancellation 60 days from the date of this notice.

FAA requested the return of the registration certificate to the FAA Aircraft Registration Branch as established in 14 C.F.R. Section 47.41(b).

Aircraft registration renewal every third year was established in Title 14 Code of Federal Regulations, Section 47.40(c) on 10/01/10, as published in the Federal Register on 07/20/10, page 41968. The changes made at this time will keep the U.S. Civil Aircraft Register up-to-date, to provide reliable support to users of the registration system.

NOTE: Registration of N93381 was cancelled in the U.S. Registry effective 12/03/22. Reason: Registration Expired.
